## KTIK "PARTY PATROL" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KTIK ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 1419 W Bannock, Boise ID 83702, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KTIK "Party Patrol"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

Eligibility. All entries must be received by 11:59pm MT on January 31, 2019 to be eligible for the Grand Prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Contest. Failure to respond to the initial verification contact within three (3) hours of notification will result in disqualification.

Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 12. Limitations of Liability. questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
